Arkansas Angus Association Sale Rules

- 1. Each consignor must be a member of the Arkansas Angus Association.
- 2. Consignors must provide their own shavings, hay, feed, and water tubs.
- 3. There will be a **\$100 consignment fee for each lot, which MUST BE PAID UPFRONT AND NO LATER THAN SEPTEMBER 15, 2023** or animals will not be in the sale catalog. Consignment fees for cattle that sell in the sale will be applied back to the consignors' expenses during settlement. Consignment fees for cattle that are pulled from the sale after the catalog goes to print will be non-refundable.
- 4. Age limit on cows is 8 years old on sale day. Age limit on bulls is a minimum of 12 months and LESS than 4 years old on sale day.
- 5. Any calf split off of a cow will count as one-half lot for sale expenses.
- 6. Calf at side must be born in current sale year.
- 7. Any female over 24 months old; or with calf at side older than 6 months of age must be pregnancy checked safe in calf and so noted on the Health Certificate by a veterinarian.
- 8. Open heifers must be less than 20 months old.
- 9. No open cows without calf at side that is less 5 months old at side can sell.
- 10. All bulls must have passing Breeding Soundness Exam paperwork. Virgin bulls under 2 years old must have a virgin bull affidavit. All bulls with previous breeding history must be trich tested and have paperwork stating so. All bulls over 2 years old, virgin or otherwise, must be trich tested before sale. Please give all BSE, virgin bull affidavits, and trich test paperwork to Katy on Friday of sale weekend.
- 11. Bulls must exhibit frame score between or including 4.0 and 7.9. (sliding scale 47.0" to under 55.0" for 12 mo.)
- 12. Bulls will be weighed at sale facility and must have a minimum weight of 2.4 pounds per day of age with the minimum weight being 1000 pounds. (All bulls over the age of 19 months must weigh a minimum of 1500 lbs.)
- 13. Information Sheets will be available to buyers on sale day including weights and scrotal circumferences each bull.
- 14. All cattle must be parentage tested through Angus Genetics Inc. by sale day or will not be allowed to sell.
- 15. Any animal that does not meet the sale requirements must be out of the facility by 8 AM on Saturday and cannot be sold on the premises.
- 16. Sale Committee will set the sale order.
- 17. Please remove all tags except sale lot tag by sale morning.

- 18. All cattle will be clipped those not clipped will sell last.
- 19. All registrations and breeding information shall be in order.
- 20. Herd performance records processed through the American Angus Association's Angus Herd Improvement Record (AHIR) are highly recommended.
- 21. Cattle shall be tested free or have no carrier ancestor of Arthrogryposis Multiplex (AM), Neuropathic Hydrocephalus (NH), and Contractual Arachnodactyly (CA).
- 22. Each animal selling including calf at side of dam must have a valid health certificate issued within thirty (30) days of the sale. Certified herds must have Brucellosis bleed dates and anniversary dates listed.
- 23. Each animal is guaranteed by the consignor.
- 24. All animals must have legible and healed tattoos corresponding to registration certificates.
- 25. All eligible females shall be calfhood vaccinated for Brucellosis (Bangs).
- 26. All animals must be free of active ringworm lesions, warts, mange and lice.
- All animals will be vaccinated for a minimum of the following: BVD (Bovine Virus Diarrhea); IBR (Infectious Bovine Rhinotracheitis); PI3 (Para-Influenza 3); BRSV (Bovine Respiratory Syncytial Virus); 7 Way Clostridium; and Lepto-Vibro.
- 28. NO SHRINKAGE ALLOWED!
- 29. Those transferring their own papers/electronic transfer must do so within 30 days of sale.
- 30. Standard 30 to 45 days on settlement after the sale applies.
